

# COMPLIMENTARY PERSONAL ACCIDENT INSURANCE POLICY ISSUED BY AIA SINGAPORE PRIVATE LIMITED TERMS AND CONDITIONS

Date: 03 September 2021 ("Effective Date")

By subscribing to this "Add On" Service offered by Diamond Electric Pte Ltd ("Diamond Electric") (this "Promotion") all customers accept the following terms and conditions:

### 1. Definitions

- (a) "Customer" means any person who signs up for the following plans:
  - i. 'Freedom RES' Plan
  - ii. 'Freedom BIZ' Plan
  - iii. 'Freedom (Carbon Neutral) RES' Plan
  - iv. 'Freedom (Carbon Neutral) BIZ' Plan
- (b) "Customer Personal Data" means Personal Data which any customer or prospective customer discloses to Diamond Electric, or which Diamond Electric processes on behalf of any customer or prospective customer, pursuant to this Agreement.
- (c) "Diamond Electric Representatives" means the employees, officers, agents, and other such authorised representatives of Diamond Electric.
- (d) "Offer" means the offer of the Service following the sign up of Diamond Electric's electricity plan(s).
- (e) "Personal Data" means data, whether true or not, about an individual who can be identified (a) from that data alone, or (b) from that data and other information which Diamond Electric has or is likely to have.
- (f) "Freedom Plans" means the electricity supply plans offered by Diamond Electric. Refer to Clause 1 (a) for the full list of eligible electricity plans.
- (g) "Service" means a complimentary Personal Accident Insurance Policy (comprising AIA Star Lite plan or AIA Solitaire Lite plan) with coverage of up to six (6) months (consisting of one (1) policy of a term of six (6) months, issued by AIA Singapore Private Limited ("AIA Singapore"), which include the following benefits:
  - 24 Hour worldwide personal accident cover; and
  - Cover for outpatient and inpatient medical expenses arising from treatment for an injury due to accident.

## 2. Complimentary Promotion

This Promotion is offered in good faith and is complimentary. Diamond Electric takes no responsibility for "AIA Singapore's Obligations" performance of the Service and any loss or damage suffered by the Customer as a consequence thereof.

# 3. Offer

The Offer for the Service is made by AIA Singapore or its authorised representatives.

- i. For Freedom RES & Freedom (Carbon Neutral) RES Plans:
  - A member of each household is entitled to six (6) months' worth of personal accident



coverage which comprises one (1) individual policy, for a term of six (6) months. Each household may choose only one person to be insured under the policy; or

ii. For Freedom – BIZ & Freedom (Carbon Neutral) – BIZ Plans:
An individual designated by the company is entitled to six (6) months' worth of personal accident coverage which comprises one (1) individual policy, for a term of six (6) months. Each company may designate one person to be insured under the policy.

# 4. Validity of Promotion

The Offer must be redeemed within six (6) months of signing up to a Freedom Plan with Diamond Electric.

### 5. Eligibility and Selection

- (a) Only residential and commercial premises located in Singapore are eligible for this Promotion.
- (b) Diamond Electric reserves the right to refuse this "Add On" Service to any Customer and AIA Singapore is not responsible or liable for Diamond Electric's exercise of its discretion and rights under these terms and conditions.

### 6. Promotion

- (a) This Promotion is not redeemable for cash or any other products or services unless stated otherwise by Diamond Electric, and it cannot be transferred or exchanged.
- (b) This Promotion is not valid with any other "Add On" promotions offered by Diamond Electric.
- (c) Diamond Electric reserves the right to amend the terms and conditions of, or suspend or terminate, this Promotion at any time without prior notice.
- (d) For redemption, the Customer, after providing the required consents to Diamond Electric, will be contacted directly by an authorised representative of AIA Singapore to organise the date/time of service and provide the necessary additional information and documentation as may be required.
- (e) This promotion is limited to:
  - i. one (1) per household for residential premises only; or
  - ii. one (1) per account held by the company only.

### 7. Personal Data

- (a) You agree that your personal data may be collected, used, and disclosed in order to provide you the Service. - (b) Diamond Electric shall not, and shall take all steps to ensure that each Diamond Electric Representative shall not, transfer Customer Personal Data to a place outside Singapore without the Customer's prior written consent.
- (c) Diamond Electric shall protect Customer Personal Data in Diamond Electric's control or possession by making reasonable security arrangements (including, where appropriate, physical, administrative, procedural, and information & communications technology measures) to prevent unauthorised or accidental access, collection, use, disclosure, copying, modification, disposal or destruction of Customer Personal Data, or other similar risks.
- (d) Diamond Electric shall only permit authorised personnel to access Customer Personal Data on a need-to-know basis.



- (e) Where Diamond Electric provides Customer Personal Data to AIA Singapore or its authorised representatives, Diamond Electric shall make reasonable efforts to ensure that the Customer Personal Data is accurate and complete before providing the same to AIA Singapore or its authorised representatives. Diamond Electric shall put in place adequate measures to ensure that the Customer Personal Data in its possession or control remains, or is otherwise accurate and complete. In any case, Diamond Electric shall take steps to correct any errors in the Customer Personal Data, as soon as practicable.
- (f) Diamond Electric shall not retain Customer Personal Data (or any documents or records containing Customer Personal Data, electronic or otherwise) for any period of time longer than is necessary to serve the purposes of this Agreement.

### 8. Indemnity

Each Customer releases and indemnifies Diamond Electric and its officers, shareholders, employees, agents, directors, affiliates, assigns, suppliers, licensors, promoters, and agencies ("Representatives") connected with this Promotion against all liability, cost, loss or expense arising out of acceptance of the Service or participation in this Promotion including (but not limited to) damage to property and whether direct, consequential, or reasonably foreseeable due to a negligent act or omission. IN NO EVENT WILL DIAMOND ELECTRIC OR ITS REPRESENTATIVES BE LIABLE FOR ANY INDIRECT, SPECIAL, INCIDENTAL, PUNITIVE, EXEMPLARY, OR CONSEQUENTIAL DAMAGES ARISING OUT OF THE USE OR INABILITY TO USE THE SERVICE.

# 9. Governing law

This Agreement is governed by the laws of Singapore.
